Doc. PhDr. Jan Němeček, DrSc., born 1963 - historian. He studied Czech language and history at the Faculty of Arts, Charles University in Prague. Since 1995 he has been working at the Institute of History of the Czech Academy of Sciences; in 2005 he was appointed Deputy Director. He studies Czechoslovak history, in particular its political and diplomatic aspects. He is the author or co-author of twelve monographs (for which he received several Czech and foreign awards), 26 book series and over 120 scientific studies that were published both at home and abroad. Since 1996 he has led a major editorial project entitled Dokumenty československé zahraniční politiky.
